Affiliation Program Service Rules & Agreement

Definitions

In this document, the following terms are used in the following terms, unless expressly stated otherwise or otherwise shown in the context:

- Michael Sousa = Michael Sousa, is located at Niasstraat 371, Amsterdam, The Netherlands, is registered in the Commercial Register of the Chamber of Commerce under Chamber of Commerce No. 68513240;
- 2. Website = the website <u>www.michaelferreirasousa.com</u>;
- 3. Month/Monthly = thirty consecutive days;
- Week/Weekly = seven consecutive days;
- 5. You = the individual agreeing with this document, and making use of the affiliation service

Which products or services are included in the Affiliation Program?

The affiliation program only includes Social Media Services offered by Michael Sousa.

How do you refer people to us?

How you share or promote our services is up to you, of course, under the common sense that no prohibited actions are conducted.

The referred person only counts towards your list if they name you when reaching out to us, or if you send us the details beforehand.

How does our Affiliation Program work?

When you refer someone to us and that person takes a membership with us. You receive a 30% discount to give away to another new user to try the service out.

If the same referred person renews for another month, you receive 5% of the value of their membership (excluding taxes, insight boosts, and eventually applied discounts).

Example:

You refer us to Person A. Person A takes a membership of €230 (=€190,08 without the 21% sales tax). You receive a 30% discount to give away. If the person decides to keep renewing. You would receive €9,50 each month from only that person. Let's say you refer 50 people with the same membership named above and they keep renewing, that would result in a €475 monthly payout for you.

When are my funds released to my account?

The funds earned by referring people are withheld for one month until they're "Released" to your account. This is to counter fraudulent activity or other prohibited actions. Unless we detect or suspect fraudulent activity. In that case, we can withhold the funds for a longer period.

Example:

You have referred us to Person A. Person A renews another time on 08-02-2023. And you earn X amount of funds on that purchase. The earned funds will be released to your account on 09-03-2023¹.

How does the payout work?

The available funds on your account need to be at least €50 or higher to be paid out. We will notify you by e-mail, with the e-mail known to us when that threshold is reached². You can keep a maximum threshold of €1.500 on your account for 3 months. If the maximum threshold is reached within 3 months, you will receive an e-mail to confirm the payout³. Please keep in mind that processing fees will be deducted from your balance by PayPal when your funds are paid out. PayPal may also subtract additional fees depending on your PayPal account type and country.

Taxes and other law-imposed rules or fees.

If it's required by your country or place, you the client and receiver of the payment have the responsibility to report the amounts to the tax authorities in your country. Or to report the payment to any other imposed authority that demands that. Michael Sousa cannot be held liable for any not reported amounts on your side.

Account Responsibility

At all times the responsibility of your account on our website remains with you the client. Never share any access to your account or your credentials. Michael Sousa cannot be held liable for the deletion or any changes to your account. The client agrees to use this program at his own risk and it does not give the client the right to complain or to dissolve this agreement.

Obligations of the customer

The customer shall ensure that all information provided to Michael Sousa is correct and complete at the conclusion of the agreement. If the data supplied by the customer is incomplete and/or incorrect, this will be entirely at your expense.

Fraud or prohibited actions

If we detect any fraudulent activity or any other prohibited action. We have the right to temporarily disable your account and withhold your funds while we investigate the issue. If the investigation results are positive, we have the right the close and delete your account permanently and seize any funds that are linked to your account.
